Scholarship funds are sent directly to the respective schools and credited to the student's tuition account. An agreement is signed by the student in the year awarded and verification is obtained from the school annually.

The Institute also provides funding for Fellowship Awards, ranging from \$150 to \$1,500. The Fellowship Awards offer support to qualified Mitchell Scholars and alumni in their pursuit of internships, service learning, and study abroad experiences that offer ongoing personal and professional development. These funds empower Scholars to pursue enriching opportunities regardless of financial factors.
